

GOOD2GROW REWARDS PROGRAM TERMS AND CONDITIONS

BY PARTICIPATING IN THIS PROGRAM DURING THE PROMOTION PERIOD, YOU AGREE TO THESE OFFICIAL TERMS AND CONDITIONS, WHICH ARE A CONTRACT. SO READ THEM CAREFULLY BEFORE PARTICIPATING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE RELEASED ENTITIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

THE PROGRAM IS ONLY OPEN TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE 18 YEARS OF AGE OR OLDER. VOID WHERE PROHIBITED BY LAW OR RESTRICTED BY LAW.

PROMOTION PERIOD: The good2grow Rewards Program (the “Program”) begins at 12:00:00 AM US Eastern Standard Time (“EST”) on January 1, 2024 and ends at 11:59:59 PM EST September 30, 2024 (the “Promotion Period”).

The Program includes three (3) entry periods (each an “Entry Period”) as outlined in the chart below:

By participating, participant (“Participant”) agrees to be bound by these Official Terms and Conditions and the decisions of good2grow, LLC (the “Sponsor”), in Sponsor’s sole and absolute discretion, are binding and final on matters relating to this Program. The computer clock of the Administrator is the official time-keeping device in the Program.

This Program is in no way sponsored, endorsed, administered by, or associated with the social media platforms where content may be posted or shared (Facebook, Instagram, etc.), collectively (“Social Media”)

ELIGIBILITY: Program is open only to legal residents of the fifty (50) United States and District of Columbia (NOT including residents of Puerto Rico or other U.S. Territories), who are at least eighteen (18) years of age or the age of majority in their state of primary residence (whichever is older) at time of Account registration. Employees, officers and representatives of the Sponsor, Southern Made Services, LLC (the “Administrator”), Fandango Loyalty Solutions, LLC (“Fandango”), good2grow LLC and each of their respective parents, affiliates, subsidiaries and web-design, advertising, marketing, fulfillment, judging and promotion agencies, or other agency involved in the administration, development, fulfillment and execution of this Program, and their immediate family members, as defined below, of each, and those persons living in the same households, whether or not related, are not eligible to participate in the Program.

Sponsor reserves the right to suspend, cancel or terminate the Program, or otherwise change any of the terms herein, including, but not limited to, making changes that may adversely affect the value of coins ("Coins") or rewards ("Rewards") already accumulated and the right to certain Rewards. Any changes will be posted on the Collectors App ("Collectors App"), and the date these Terms and Conditions were last updated will be included at the top of the Terms and Conditions.

Any and all information provided in connection with this Program is subject to the Sponsor's Privacy Policy available at www.good2grow.com/privacy/. By entering in the Program, Participant hereby agrees that the Sponsor may collect and use their personal information submitted with their Account. Among other things, the information Participants provide may be used to send company updates and announcements from the Sponsor concerning the company and its products. At the time of registration, Participant may be given the opportunity to opt-in to receive further communications from the Sponsor. Participant is not required to opt-in.

HOW TO PARTICIPATE: Download the good2grow Collectors App on a compatible smartphone or other mobile device and/or open the app. Create an account ("Account") and then follow the instructions on screen to complete Participant's Account or log into Participant's existing Account. Earn Coins by participating in specified actions in the Program.

Activities to earn Coins are as follows:

- Reward 1 coin
 - Add Top to Wishlist: Follow the instructions provided for Participant to add a good2grow character spout Top ("Top") to their Wishlist to earn 1 Coin . A Wishlist is a collection of Tops you would like to own. Participant may add multiple Tops to their Wishlist but will receive 1 Coin for the first 5 Tops added.
 - Add Top to Favorites: Follow the instructions provided to add a character Top to Participant's Favorites to earn 1 Coin . A Favorite is a Top you love. Participant may add multiple Tops to their Favorites but will receive 1 Coin for the first 5 Tops added.
 - Add a Top: Follow the instructions provided to Add a Top. Once the Top has been added Participant will receive 1 Coin . Participant may add multiple Tops but will receive:

- 1 Coin for the first 5 Tops added if Participant is a Rookie Level
- 1 Coin for the first 5 Tops added if Participant is a Collector Level
- 1 Coin for the first 10 Tops added if Participant is a Star Level
- 1 Coin for the first 15 Tops added if Participant is a Pro Level
- 1 Coin for the first 20 Tops added if Participant is an Elite Level
- Log-in: Log-in to Participant's Account and spend at least 3 minutes to earn 1 Coin. Participant can log-in as many times as they would like but will only receive 1 Coin for the first 5 log-ins.
- Solve a Top Reveal Puzzle: Follow the instructions provided to solve the puzzle to receive 1 Coin. Participant will receive 1 Coin for each puzzle. Participant may still play archived games if they did not solve it while active, but they will only receive a coin for solving a puzzle if it is active.
- Reward 3 Coins
 - Receive a Badge: Participant will earn a virtual icon Badge for each Level achieved, up to 4: Collector Badge, Star Badge, Pro Badge and Elite Badge. Each badge will receive 3 Coins.
 - Scan a Top: Follow the instructions provided to scan a Top to earn Coins. The number of coins earned for each scanned Top depends on the rarity of the Top. The rarity of the Tops will be noted in the Collector's App.
 - Participants will earn 3 Coins for common Tops.
 - Participants will earn 4 Coins for rare and lucky Tops.
 - Participants will earn 7 Coins for special edition or Tops in the vault.

Click to launch the camera on or mobile device and grant permission for the Program to access your camera. Follow the prompts and hold the good2grow bottle top clearly in front of camera window. Place the good2grow bottle on a flat surface in a bright light and then click the scan button. Once the Top has been scanned Participant will receive verification. Participant may scan multiple Tops to their collection but will receive:

- Coins based on rarity of the Top will be earned for the first 10 Tops added if Participant is a Rookie Level
- Coins based on rarity of the Top will be earned for the first 10 Tops added if Participant is a Collector Level
- Coins based on rarity of the Top will be earned for the first 20 Tops added if Participant is a Star Level

- Coins based on rarity of the Top will be earned for the first 30 Tops added if Participant is a Pro Level
 - Coins based on rarity of the Top will be earned for the unlimited Tops added if Participant is an Elite Level
- Play Games: Follow the instructions provided and play a game to receive 3 Coins. Participant may play each game as many times as they would like but will only receive 3 Coins for each game up to 2 times. A Participant's score in the game will not increase or decrease the number of Coins received.
- Reward 10 Coins
 - Create an Account on the Collector's App: Follow the instructions provided on on-screen to receive 10 Coins when Participant initially signs up for the Program. Participant can only receive these 10 Coins once.

 - Follow good2grow on Instagram: Create or log in to Participant's Instagram account. Follow @good2growdrinks on Instagram to receive 10 Coins. Participant can only receive these 10 Coins once.
 - Like good2grow page on Facebook: Create or log into to Participant's Facebook account. Like @good2grow page on Facebook to receive 10 Coins. Participant can only receive these 10 Coins once.
 - Complete a Spout or PODZ Franchise Collection: Add all Tops within a franchise collection to receive 10 Coins. Participants can only receive these 10 Coins once per franchise. There are 73 franchises in total.
 - Refer a Friend: Follow the instructions provided to invite friends and family to participate in the Program. When a referred user signs up for the Program and confirms their account via email, Participant will receive 10 Coins. Limit of 5 referrals per Participant per Entry Period for a maximum of 200 Coins per Participant per calendar year. Participants must only refer friends and family members with whom they have an existing relationship with.

TERMS FOR EARNING COINS: Additional methods by which a Participant can earn Coins may be offered during the Program. All details with respect to these methods, including the number of Coins a Participant can earn and the length of time during which the additional method(s) will be available, will be determined by Sponsor in its sole discretion, and will be outlined on the Collector App. Sponsor has no obligation to provide any additional methods of Program participation.

Once Participant accumulates enough Coins, Participant will achieve a different level ("Level"). Based on the Level earned at the end of each Entry Period Participant will receive one (1) entry into a sweepstakes ("Entry") into the prize pool associated with Participant's Level and all earn all Rewards associated with their Level earned. Participants that have achieved Rookie Level will not receive an Entry or any Rewards.

Sponsor reserves the right to modify the Coin value(s) for a Level, at any time and for any reason, during the Promotion Period.
